Year-over-Year Revenue Diversification

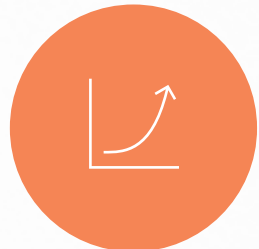




Q2 2026 Year-over-Year Gains: Second Consecutive Profitable Quarter

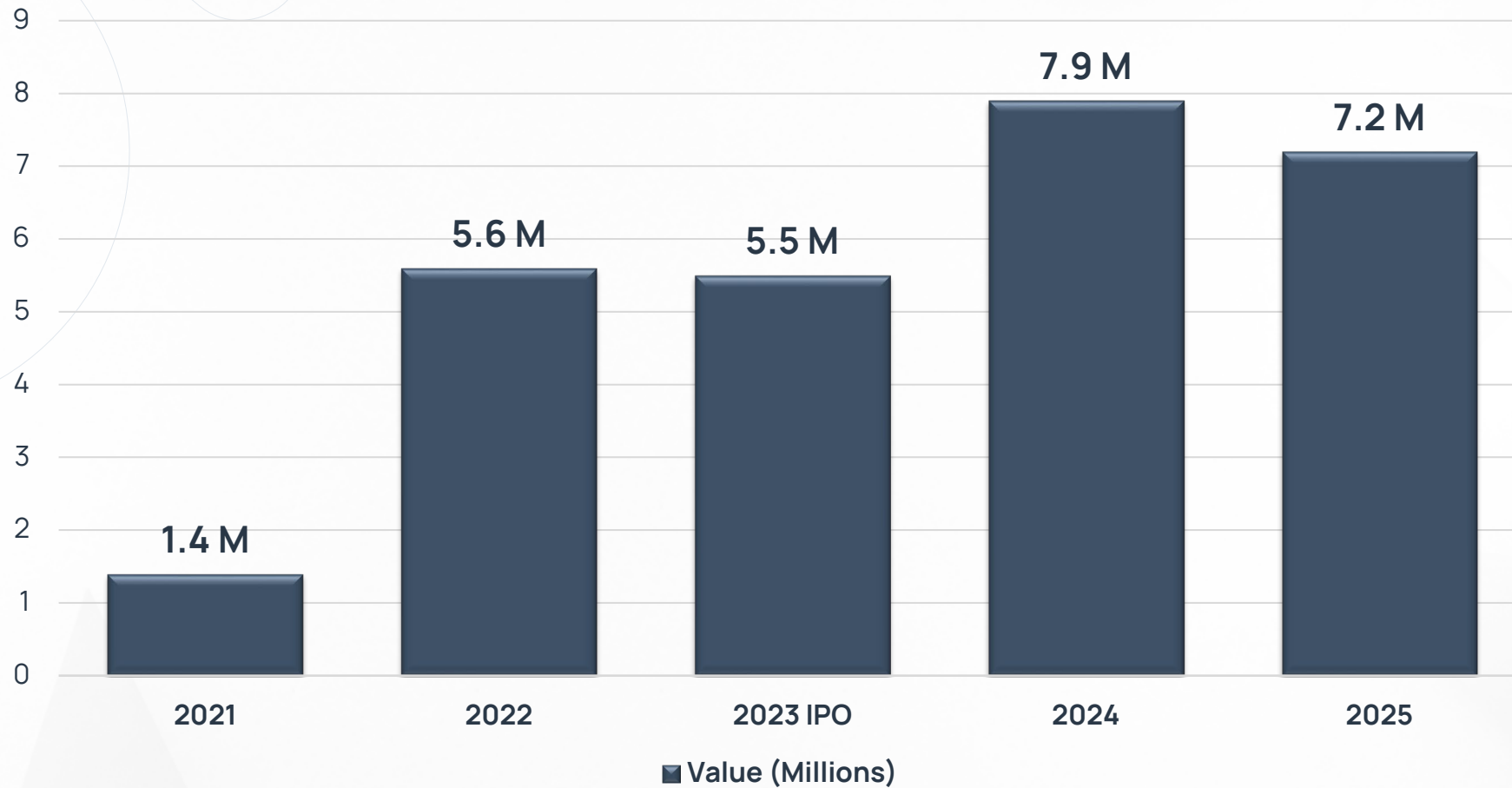
