On June 18, 2024, Syra Health Corp. (the "Company") held its Annual Meeting of Stockholders (the "Annual Meeting"). A total of 15,222,830 shares of common stock (including 833,334 shares of Class B common stock with each share of Class B common stock having 16.5 votes per share), constituting a quorum, were represented in person or by valid proxies at the Annual Meeting. The final results for each of the matters submitted to a vote of stockholders at the Annual Meeting, as set forth in the Definitive Proxy Statement, filed with the Securities and Exchange Commission on April 24, 2024 are as follows:
